The Company expects to report a loss for the quarter ended September 30, 2011 of approximately \$510,000, compared with a net loss of \$589,000 for the quarter ended September 30, 2010. The estimated \$80,000 decrease in net loss for the current quarter, compared to the corresponding prior quarter, is primarily attributable to a \$260,000 decrease in costs and expenses, partially offset by a an approximate \$200,000 increase in other expense (consisting primarily of finance costs paid in stocks and warrants, related party).
